These individuals apply a broad range of competencies related to the health and welfare of greyhounds, racing ethics and integrity as well as competencies that are more technical. They are required to use discretion, judgement and relevant theoretical knowledge.</p> <p>Licensing, legislative, regulatory or certification requirements may apply to this qualification. Refer to your state or territory Controlling Body or Principal Racing Authority for current licence or registration requirements.</p>																			
<p>Entry Requirements</p> <p>There are no entry requirements for this qualification.</p>
