Knowledge Evidence

An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:

- types of incidents involving large animals and what can go wrong
- own responsibilities under current health and safety and animal welfare regulations, codes and organisational policies and procedures
- potential hazards and risks at a large animal incident scene, including:
 - weight and size of animal
 - companion or other animals in the vicinity
 - · environmental hazards uneven or wet terrain, weather, electrical hazards, noise
 - actions of people, including body language and irrational or emotive behaviour
 - zoonotic diseases including, bites, scratches and contact with body fluids
- large animal sensory perceptions and how senses can influence behaviour and reactions
- common signs and body language of distressed large animals relevant to the workplace or event
- · behaviours of large animals relevant to incident scenes, including:
 - prey species motivated by fear 'fight (kick, bite) or flight (run)' reactions
 - animal flight zones and point of balance used to make animals move
 - herd behaviours crowding of animals, anxiety when separated form herd
 - unpredictable and reactive behaviours, including butting, biting, kicking, crushing, impaling/goring
- features of control and command at incident scenes, including:
 - roles of team members, including incident controller and veterinarian
 - communication protocols
 - incident zones (hot, warm, cold) and personnel allowed in each
 - safe zones related to animals
 - basic principles of large animal rescues:
 - ensure animal is restrained using a head collar
 - work safely around a chemically restrained animal
 - always have a safe egress
 - never release an animal unless there is a safe holding area
 - work as a team
- safe working behaviours around large animals, including:
 - stay calm, move slowly and confidently, act in a non-threatening, unhurried manner
 - ensure the animal is aware of your presence by speaking in low rhythmic tones
- basic rescue equipment, including:
 - headcollars, long lead ropes
 - ropes, stops/straps
 - crooks, extension poles, strop guide, J-hooks
 - rescue glide
- safety and hygiene practices working with animals, including:

- biosecurity and hygiene
- tool decontamination
- use of personal protective equipment (PPE)
- keeping the scene free of obstacles and tripping hazards
- manual handling techniques
- minimising noise and distractions for animals.

Assessment Conditions

Assessment of skills must take place under the following conditions:

- physical conditions:
 - skills must be demonstrated in a workplace setting or an environment that accurately represents workplace conditions
- resources, equipment and materials:
 - animal mannequins
 - incident scene information involving large animals to address the performance evidence requirements.
