#### **Performance Evidence**

## **Knowledge Evidence**

- workplace requirements applicable to health and safety in the workplace for establishing and monitoring hydroponic crops
- hydroponic crop nutrient solution techniques, including:

  - ebb and flow
  - fogponics
  - passive sub-irrigation

  - · top-fed deep water culture
- types of hydroponic substrates, including:

  - coconut coir
  - perlite
  - rockwool
  - vermiculite
- types of hydroponic nutrient solutions, including:
  - inorganic
  - organic
- · nutrient solution testing and analysis procedures and equipment, including:
  - electrical conductivity meters
  - ph meters
  - litmus paper
  - ph indicator strips
  - colorimeters
- nutrient solution measuring procedures, tools and equipment, including:
  - · graduated cylinders
  - measuring spoons
- environmental impacts associated with establishing and monitoring hydroponic crops
- industry and workplace biosecurity procedures.
