

# Crops, Pastures & Seed Project



## Summary of Validation Feedback, Responses and Actions

June 2021

This project includes the development of three units of competency and the review of five qualifications and 60 units of competency within the Agriculture, Horticulture and Conservation and Land Management Training Package. The final draft materials were developed as a result of feedback provided by stakeholders and Subject Matter Experts (SMEs) during the validation period May 27 – 17 June 2021.

Validation meetings were held with Subject Matter Expert working group on the 31 May 2021 and 4 June 2021 at which all documents were validated by industry representatives.

Validation feedback was also sought and received from stakeholders via (phone, emails and surveys). The table below provides an overview of the groups and jurisdictions that have provided feedback during this phase of the project.
