They use discretion and judgement in the selection and use of available resources and complete routine activities.</p> <p>No licensing, legislative or certification requirements apply to this unit at the time of publication.</p>

Complete harvesting operations	4.1 Clean and store equipment, attachments and other ancillary equipment according to hygiene and biosecurity procedures 4.2 Apply treatments to crop according to harvest strategy 4.3 Dispose waste according to workplace and environmental procedures 4.4 Ensure harvesting equipment is moved between sites and on public property according to workplace procedures and regulatory requirements 4.5 Maintain records and documentation according to workplace procedures
