<p>Packaging Rules</p> <p>To achieve this qualification, competency must be demonstrated in:</p> <ul style="list-style-type: none"> • 12 units of competency: <ul style="list-style-type: none"> • 2 core units plus • 10 elective units. <p>Elective units must ensure the integrity of the alignment between the qualification and Australian Qualification Framework (AQF) and contribute to a valid, industry-supported vocational outcome. The electives are to be chosen as follows:</p> <ul style="list-style-type: none"> • at least 3 units must be selected from Group A • at least 3 units must be selected from Group B • remaining elective units can be selected from Groups A, B or C and can include up to 2 units from any currently endorsed Training Package or accredited course.
