Stakeholder Feedback Report - Validation

Draft qualifications, units of competency and skill sets for the Organic Producion and Composing Projects were made available on the Skills Impact website for stakeholder review and validation from May 19 to June 20. Please visit the website to view a full list of the documents that were submitted for consultation during this phase.

Feedback was received from a variety of stakeholders around the country via email, the Skills Impact Feedback Hub, webinars, phone and email. Of the 26 people who participated in this project overall, 21 also provided support for the components produced at this Validation stage (see table). Out of these 21, 12 people represented organisations, three were from peak industry bodies, six from RTOs.
