The question about the inclusion of both AHCPRK2x1 and AHCPRK2x2, i.e. whether one or both would be needed for all the skilled job roles in pork production is one for industry. Obviously including both of these would ensure that holders of this qualification have handled and cared for pigs as required in the performance evidence for each unit. Looking at the Certificate III in Pork Production electives in Groups A and B, it seems clear that holders of this qualification are expected to carry out hands on duties in a piggery. Both PRK units in question would support many of the elective units, especially AHCPRK2X2 in terms of the application of welfare requirements.

Thank you for the feedback.

The SMEWG expects that the PE in this and other poultry (AHCPLY) units will be assessed in a poultry production work site which will make it easier for RTO to collect evidence. It is noted that most of the RTOs with the Poultry qualification on scope currently assess these units on farms.

The SMEWG (including representatives from both Industry and RTOs) has advised that whenever live animals are used as part of training and assessment of the AHCPLY units, it will be as part of routine animal husbandry practices, which do not require approval by an Animal Ethics Committee.

The use of replica animals and simulated scenarios was discussed by the SMEWG as potential alternatives to using real animals (both live and dead) in the training and assessment of the AHCPLY units. The SMEWG made it clear that in addition to the skill development required by workers in these industries, it is in the best interests of biosecurity, animal welfare, worker safety and public health that live animals are used in the training and assessment of these units.

In keeping with the unit's outcomes (e.g. - monitoring poultry environments), the SMEWG advised that performance must be demonstrated over a minimum period of time in this unit, but agreed to reduce the time frame from 7 to 5 days. The AC has been updated to state "the five days specified in the performance evidence can be consecutive or non-consecutive".

This 'performance over time' approach is also consistent with ASQA's definition of competency as 'the consistent application of knowledge and skill to the standard of performance required in the workplace. It embodies the ability to transfer and apply skills and knowledge to new situations and environments". Note- that unit has also been revised and recoded to reflect AQF level 3 outcomes.

This is a minimum of 60 birds. From the 60 birds:

The individual must also have treated at least five different birds as directed, including:

- •used appropriate techniques and location to administer treatments
- •used enterprise criteria to identify at least three cull birds
- •isolated at least one bird showing signs of illness
- •removed at least one dead or non-viable bird.

Will these be difficult to achieve from a minimum of 60 birds?

# Consideration and Proposed Resolution: Noted

Thank you for the feedback.

The SMEWG considered the feedback and has increased the number of birds to be given treatments from a minimum of 5 to at least 20 (or 1 of the groups) required for the PE, which the SMEWG did not consider difficult as the treatment can be administered to the birds by adding it to their drinking water. The SMEWG also advised that the 3 birds for potential culling, 1 bird showing sign of illness and 1 dead bird can be sourced from the 60 birds used for the other parts of the PE, or sourced from other poultry.

The SMEWG (that includes industry and RTO representatives) envisaged that this unit and the other Poultry units would be trained and assessed in a commercial poultry production site, where the birds required in the PE would be readily accessible. Note - the unit has been revised and recorded to reflect AQF level 3 outcomes.

While it may appear that AHCBIO303 Apply biosecurity measures may be suitable, it lacks several important commercial poultry specific outcomes required to protect this industry, which is why AHCPLY3X4 is Core of the Certificate III in Poultry Production.

Below are some of the unique and critical outcomes that are covered only in the revised AHCPLY3X4:

- 1. Interpretation of the National Farm Biosecurity Manual for Poultry Production, and other Codes of Practice, industry and enterprise requirements related to biosecurity for poultry production.
- 2. Implementation of biosecurity procedures on detection of disease or pest, including wild birds and other pests that can spread pathogens in poultry and the wider community.
- 3. Review of biosecurity controls and suggesting of changes to improve enterprise biosecurity procedures in poultry production sites.
- 4. FS with practical numeracy skills used in the poultry industry.
- 5. PE to demonstrate the application of poultry production biosecurity practices.
- 6. KE includes essential poultry specific biosecurity information.

The SMEWG also raised concerns about replacing AHCPLY3X4 with a generic biosecurity unit. The generic unit can be achieved in a non-poultry production context (say in a general agriculture or horticulture qualification). If the generic unit was the unit used in the Certificate III in Poultry Production, a person could receive a credit transfer for this unit, and not develop the critical poultry specific biosecurity skills and knowledge required to safeguard the industry.

In this unit, the administration of treatments to pigs is controlled by a predetermined Farm Treatment Plan or an Approved Medication List, and carried out according to highly controlled enterprise procedures, including safe and low stress animal handling techniques. As per the Assessment Conditions, it will be as part of the regular work program on a farm, when pigs are scheduled to receive treatments.

The use of replica animals and simulated scenarios was discussed by SMEWGs as potential alternatives to using real animals (both live and dead) in the training and assessment of the AHCPRK units. The SMEWG advised that in addition to the skill development required by workers in these industries, it is in the best interests of biosecurity, animal welfare, worker safety and public health that live animals are used in the training and assessment of these units.

Thank you for the feedback. Following SMEWG advice, some adjustments have been made to the skill sets in this project.

All of the seven existing Skill Sets in the Poultry sector are proposed for deletion and will be replaced with five new Skill Sets that reflect the Specialisations added to the redesigned Certificate III in Poultry Production. The new Skill Sets were designed to meet industry needs, keep the units required to a minimum and provide pathways/credit toward the redesigned Certificate III. The result is Skill Sets that require between 5 and 10 units.

One of the existing Pork Sector Skill Sets is proposed for deletion. The number of units required in the other two Skill Sets has not changed, based on industry advice. For example, the Pork Industry Stockperson Skill Set that requires 8 units reflects the minimum requirements to work unsupervised in the Pork Industry, as well the compliance requirements of the Code of Practice for Welfare of Animals (Pigs)
