Note: both the pork and poultry industries have been greatly affected by Japanese encephalitis, foot and mouth and avian flu respectively over the course of the project. Access to many stakeholders was limited through the validation period as they were responding to these threats.

This involves a consideration of the information provided, views of industry stakeholders and from people who are part of the Subject Matter Expert Working Group (SMEWG) process. Resolutions are constructed to consider the needs and views of stakeholders to the extent possible, and to comply with the Standards for Training Packages 2012. The resolutions may represent a compromise on one or more stakeholder views with the aim of a workable outcome for industry, State and Territory Training Authorities (STAs) and training providers.

Rationale is that current ACMGEN315 unit says worker with clients, but most workers won't do this task.

The SMEWG advised that both AHCLSK331 Comply with industry animal welfare requirements and AHCPRK2X1 Care for health and welfare of pigs should remain in the core of this qualification, because they have different outcomes. Both of these outcomes have been deigned as core knowledge and skill requirements for those completing the qualification. The units complement each other well, as LSK331 is a broader, more holistic livestock unit, and PRK2X1 is pork specific.

ACMGEN315 Communicate effectively with clients and team members has been replaced in the General Electives of the qualification with BSBXCM301 Engage in workplace communication. The SMEWG advised that AHCWRK204 Work effectively in the industry is not appropriate to list in this qualification, as this unit's outcomes are generic and not at the appropriate level for the jobs covered by the qualification.

We have encouraged engagement with the A and B unit blocks in the following ways in the packaging rules:

The number of units selected from Groups A and B was discussed with the SMEWG and the current wording was confirmed as the most appropriate -

- at least 2 units must be from elective group A
- at least 5 units must be from elective group B

Based on the packaging rules, a minimum of 7 of the 11 electives (63%) must be selected from Groups A and B, while it remains possible for all 11 elective units being selected from these groups. Advice will be added in the AHC Companion Volume Implementation Guide to say industry strongly recommends elective units be selected from Groups A and B as the most useful for working in commercial pork production.

Therefore, AHCPLY3X3 Clean and disinfect poultry sheds has been removed from this Skill Set. The SMEWG members do not believe that this is a specialised position within the sector, and therefore, a large skill set is the most appropriate product at this time.

An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.

There must be evidence that the individual has safely and effectively cared for at least three different individual or groups of pigs over a period of 5 days. Each group must include at least three pigs. For each group, the individual must have:

The individual is required to:

- identified at least identified at least two hazards, and assessed and controlled and/or reported associated risks
- identify one (1) hazard or potential hazard and how this hazard was or could be controlled or reported to be rectified
- select, check and correctly fit appropriate personal protective equipment (PPE)
- used safe and low stress animal handling techniques
- maintained feed and water availability
- maintained pig environments, including:
- cleaned feeding and watering equipment
- identified and reported signs of pest and/or predator activity
- disposed of waste materials according to environmental requirements
- checked pig for signs of abnormal discharge [Not relevant to this unit (save for Farrowing and mating units)]
- monitored and reported basic pig health and identified signs of:
- ill health, injury or distress
- abnormal or depressed appetite
- non-routine behaviour

The individual must also have treated at least five different pigs as directed, including: [(Quantity is unrealistic- what if there are no sick pigs? You can't assume health status and treatment needs)]

If pigs have required intervention or have been administered with animal health treatments the individual has:

- used appropriate techniques and location to administer treatments
- safely handled and stored materials used for treatments according to enterprise health, safety, environmental and biosecurity requirements
- documented all treatments provided to pigs according to enterprise requirements

In addition to the above, the individual must have: [(Again we are assuming there is a health problem or death- this may not be the case so the wording MUST and giving a quantity may not be possible)]

- isolated at least one pig showing signs of illness or abnormal behaviour according to enterprise biosecurity procedures
- removed at least one dead or non-viable pig according to enterprise biosecurity and/or environmental procedures

Where these skills cannot be demonstrated due to the ad hock nature of animal rearing a scenario or further questioning maybe necessary to gather evidence of knowledge and skills.

- checks including weight and breathing rate

- [(checking skin for red patches, scabs, bleeding, lesions, swelling, and open wounds)] Skin condition including injury, evidence of fighting or infection
- [(checking for unusual discharges from eyes, nose and genitalia)] Unusual discharge
- [(abnormal faeces)] Scouring, colour change or evidence of parasite infestation
