AMPGAM3X2	Operate a wild game harvester vehicle
Application	<p>This unit describes the skills and knowledge required to operate a field harvesting vehicle safely and hygienically.</p> <p>This unit applies to individuals who work as operators of vehicles for wild game harvesting for commercial purposes. Operators have responsibility for the operation and maintenance of the field harvesting vehicle, the loading and unloading of carcasses and the safe handling of cleaning chemicals and equipment.</p> <p>All work must be carried out to comply with workplace procedures, in accordance with state/territory health and safety, food and meat safety regulations, animal welfare regulations, legislation and standards that apply to the workplace.</p> <p>Legislative and regulatory requirements apply to wild game harvesting and are enforced through state/territory jurisdictions. Users must check with the relevant regulatory authority before delivery.</p>

4. Clean field harvester vehicle and equipment	4.1 Clean vehicle to meet regulatory requirements 4.2 Use cleaning chemicals that meet regulatory requirements in accordance with manufacturer instructions 4.3 Clean kit and hanging pins in accordance with the management plan 4.4 Store kit and hanging pins to avoid contamination 4.5 Identify and organise any vehicle or equipment maintenance requirements 4.6 Complete records in line with regulatory and workplace requirements

Performance Evidence	
<p>An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.</p> <p>There must be evidence that the individual has checked, loaded, unloaded and cleaned a game harvesting vehicle safely and hygienically, on at least one occasion.</p>	
Knowledge Evidence	
<p>An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:</p> <ul style="list-style-type: none"> • regulations covering game harvesting vehicles • supply of required consumables • relevant sections of: <ul style="list-style-type: none"> • AS 4464:2007 <i>Hygienic Production of Wild Game Meat for Human Consumption</i> • AS 4841:2006 <i>Hygienic Production of Pet Meat PISC Report 88 – Amended 2009</i> • potable water supply for washing hands and equipment • lighting requirements to ensure hygienic processing at night • hanging requirements to maintain wholesomeness of product • importance of air flow • regulations associated with transport, loading and unloading of carcasses • causes of contamination during loading, transport and unloading • methods for minimising contamination • time requirements for refrigeration after death and sunrise • regulatory requirements for identification and traceability of carcasses • reporting and documentation requirements for harvested wild game • safe hygiene and sanitation practices to be adhered to during unloading • safe manual handling techniques • procedures for maintaining personal hygiene • work instruction for carcase receipt • field depot or wild game processing establishment requirements for receiving carcasses • workplace health and safety hazards associated with handling carcasses • ways of minimising workplace health and safety risks associated with handling carcasses • workplace health and safety hazards associated with cleaning chemicals, including use of personal protective clothing and equipment and access to first aid kit • hygiene and sanitation requirements for game harvesting vehicles • the purpose and uses of particular cleaning and sanitising chemicals • storage requirements for kit and hanging pins.

<p>Assessment of the skills in this unit of competency must take place under the following conditions:</p> <ul style="list-style-type: none"> • physical conditions: <ul style="list-style-type: none"> • skills must be demonstrated in the field while harvesting wild game animals • resources, equipment and materials: <ul style="list-style-type: none"> • field harvester vehicle • game harvesting equipment • personal protective clothing and equipment. <p>Assessors of this unit must satisfy the requirements for assessors in applicable vocational education and training legislation, frameworks and/or standards.</p>
