Summary of Feedback, Responses and Actions

05 January 2018

This project included the development of *AHC32618 Certificate III in Rural Machinery Operations* to supersede *AHC32616 Certificate III in Rural Machinery Operations*. This draft includes the redesign of 35 units of competency, and the development of two (2) new units of competency to supersede the current Agricultural Machinery training package components. The revised qualification, new and redesigned units that will be included in the AHC Agriculture, Horticulture and Conservation and Land Management Training Package are listed below.

The draft qualification, including the new and redesigned units, were available for broader stakeholder consultation and feedback between 9 November and 10 December 2017. Twenty two (22) responses were received, representing fourteen (15) training providers (National, NSW, NT, QLD, SA, VIC and WA), one (1) Curriculum Maintenance Manager (VIC), and six (6) industry (NT, QLD, VIC and WA).

Below is a summary of the issues raised and how these issues have been dealt with. This involves a consideration of the information provided, views of industry stakeholders where known, and views provided by the people who are part of the Subject Matter Expert (SME) Working Group process. Resolutions are constructed to take into account the needs and views of stakeholders as far as possible, and to comply with the *Standards for Training Package 2012*. The resolutions may represent a compromise on one or more stakeholder views with the aim of a workable outcome for industry, STAs and Training Providers.
