# 20-12 Work with Crocodiles

Summary of Feedback, Responses and Actions



#### March 2020

Draft qualifications, units of competency and skill sets for the 20-12 Work with Crocodiles project were made available on the <u>Skills Impact Website</u> for stakeholder review from 07 February until 09 March 2020. Please visit the website to view a full list of the documents that were submitted for consultation during these phases.

Feedback was received from a variety of stakeholders around the country via email, phone, the Skills Impact Feedback Hub, site visits, at face-to-face workshops and a webinar, as follows:

All State and Territory Training Authorities were informed about this project and feedback has been requested, however, the only response outside of Queensland, the Northern Territory and Western Australia, where crocodiles are found; was an email from the Analytic and Policy Services, Skills Canberra. This email stated that there are no providers or students in this course and so, the Australian Capital Territory has no comment to make.

Feedback received during the 'drafts available' period for the qualifications, units of competency and skill sets that have been developed for crocodiles has been positive, the stakeholders are extremely enthusiastic and have contributed several changes to draft documentation. All documents developed are new.,

Below is a summary of the feedback raised for the draft qualifications, units of competency and skill sets developed and reviewed for the 20-12 Work with Crocodiles project, and how these have been dealt with. This involves a consideration of the information provided, views of industry stakeholders and from people who are part of the Subject Matter Expert Working Group process. Resolutions are constructed to consider the needs and views of stakeholders to the extent possible, and to comply with the *Standards for Training Package 2012*. The resolutions may represent a compromise on one or more stakeholder views with the aim of a workable outcome for industry, State and Territory Training Authorities (STAs) and training providers.
