# **Rural Merchandising and Sales Project**



## Summary of Validation Feedback, Responses and Actions $\operatorname{May}\ 2020$

This project includes the review of one qualification and 11 units of competency, and the deletion of one unit of competency within the Agriculture, Horticulture, Conservation and Land Management (AHC) Training Package. Draft materials were developed as a result of initial input from Subject Matter Experts (SMEs) and were made available for broader stakeholder consultation and feedback between 16 September and 20 October 2019. During this time feedback was received via email, through online surveys, as well as in person at workshops or site visits, and by telephone. Input was received from nine stakeholders around Australia, including two industry employers/employees, four Registered Training Organisations, and one Government body, with the rest comprising of industry advisory organisations.

Validation feedback was invited via the online hub, email and by phone from 20 December 2019 – 28 January 2020. A validation meeting was held on 22 January 2020 with SMEs, with representatives from Industry (QLD) and RTO (WA).

It should be noted that feedback was impacted by national events at that time i.e. bushfires, drought and subsequent floods, with many representatives unable to contribute. More recently, the project has also been impacted by COVID-19, however, support has been shown through acknowledgement and support letters via email. Throughout the project, feedback has been received from a broad spectrum of industry experts from all states & territories.

As a direct result of feedback received, changes were made to the documents under review. Most notably:
