Feedback received during the 'drafts available' period for the units of competency that have been developed for timber supply sectors has been positive, with minor changes or updates suggested by stakeholders.

Below is a summary of the feedback raised for the draft units of competency developed and reviewed for the Timber Merchandising Project, and how these have been dealt with. This involves a consideration of the information provided, views of industry stakeholders and from people who are part of the Subject Matter Expert Working Group process. Resolutions are constructed to consider the needs and views of stakeholders to the extent possible, and to comply with the *Standards for Training Package 2012*. The resolutions may represent a compromise on one or more stakeholder views with the aim of a workable outcome for industry, State and Territory Training Authorities (STAs) and training providers.

Background

This project comprises the review of one qualification and four units of competency within the FWP Forest and Wood Products Training Package. One qualification and one unit of competency are proposed for deletion. Three units, that were originally on the project scope, have not been revised as they do not form part of the revised qualification.

Written submissions were received from 8 stakeholders, including 4 responses from industry organisations and associations, 2 responses from registered training organisations and 2 responses from State Curriculum Management Services.

As a direct result of feedback received between 23 January and 1 March 2020, a number of changes were made to the documents under review. Most notably, the decision not to pursue the development of a new Certificate IV in Timber Building Products Supply. This decision was taken in response to feedback from key industry stakeholders which indicated that people in timber sales roles at this level require leadership and management skills rather than further technical skills. The technical skill needs of these people are addressed in the revised Certificate III in Timber Building Products Supply. The leadership and management skills needs of this group are met by existing qualifications in the Business Services and other Training Packages.

Gov VIC	Advice is to maintain this qualification. Victoria has had enrolments in 2017, 2018 and 2019. The course is used by industry (timber retailers) and RTOs for training entry level staff in sales / merchandising roles. Advice from one Victorian RTO is that the decrease in use of this qualification over the last two years was due to circumstances that no longer exist and increased enrolments are expected in 2020 and that SIR20216 is not viable replacement for FWP20161.	The Certificate II in Timber Merchandising (FWP20616) will be proposed for deletion. The decision is based on further discussion with the Victorian RTO who provided clarifications about the use of this Cert II in the past as "the vehicle" for accessing one unit. This unit has been revised and included in the Certificate III in Timber Building Products Supply and is also listed on other FWP qualifications.			
RTO VIC	We started some discussions about training that could be delivered for Timber Merchants Australia members, which has included the Certificate II in Timber Merchandising. These discussions are still continuing but information will be going to MGA/TMA members shortly and I would expect some renewed interest in Victoria. Three additional units of competency were revised and drafted as part of this project.

The units are within the FWP Forest and Wood Products Training Package were made available on the Skills Impact website for stakeholder review from 6 April to 1 May 2020. Please visit the <u>website</u> to view a full list of the documents that were submitted for consultation during this phase.

All relevant registered training organisations (RTOs) and the few employers who used these units during the last three years were contacted by direct email and follow-up phone calls. At least one of the RTOs that provided comment also engaged with one of their employers in the provision of feedback. It should be noted that the majority of these units are in the category of units with low training and assessment activity.

Below is a summary of the issues raised for the units of competency reviewed as part of the Timber Merchandising Project, and how these issues have been dealt with.
