Performance Evidence	
<p>An individual demonstrating competency must satisfy all of the elements and performance criteria in this unit.</p> <p>There must be evidence that, on two occasions, the individual has:</p> <ul style="list-style-type: none"> • assessed the potential for fire while performing normal workplace activities • implemented fire prevention measures while performing normal workplace activities. 	
Knowledge Evidence	
<p>An individual must be able to demonstrate the knowledge required to perform the tasks outlined in the elements and performance criteria of this unit. This includes knowledge of:</p> <ul style="list-style-type: none"> • workplace policies and procedures for fire prevention • fire types including: <ul style="list-style-type: none"> • wildfires • electrical storm induced fires • arson • accidental fires • electrical fires • fire prevention methods including: <ul style="list-style-type: none"> • cutting fire breaks • clearing undergrowth • ensuring combustible materials are safely used, handled, stored and transported • ensuring the work area is clear of waste and that exits are accessible • quarantining equipment to be serviced according to workplace procedures • fire service approved fire suppression extinguishing agents • extinguishers for fires that are: <ul style="list-style-type: none"> • electrical • chemical • gas • mechanical • paper • wood or natural fires • weather conditions and their effect on fires: <ul style="list-style-type: none"> • high winds • electrical storms • lightning strikes • excessive heat and low humidity • fire risks including: <ul style="list-style-type: none"> • welding or grinding sparks • dry undergrowth • potential of equipment use and unsafe work practices to create fire • combustible materials including dry or dead scrub, tall grasses, rubbish, oily rags • waste material proximity to equipment • flammable liquids • inappropriate use, handling, storage and transport of materials and equipment • blocked or no access and exit • safe methods for using, handling, storing and transporting flammable, combustible or waste materials • methods for controlling vegetation to minimize fire risks • requirements for fire breaks.
